NOTIFICATION

In exercise of the powers conferred by the Provision to Article 309 of the Constitution of India the Governor, Tripura is pleased to make the following Rules, further to amend Tripura State Civil Service (Revised Pay) Rules, 2009, namely:-

1. Short title and commencement
 - (i) These Rules may be called the Tripura State Civil Services (Revised Pay) (fourth amendment) Rules, 2010.
 - (ii) They shall be deemed to have come into force on and from the 1st day of July 2010.

Amendment of Rule 9:

Below Sub-Rule (1) of Rule 9, a new provision '(a)' shall be inserted as follows:

"(a) The rate of increment as mentioned in Sub-Rule (1) above shall be 'three per centum (3%)' with effect from 1st July 2010."

Amendment of Rule 10:

Below Sub-Rule (7) of Rule 10, a new provision '(a)' shall be inserted as follows:

"(a) The rate of increment as mentioned in Sub-Rule (7) above shall be 'three per centum (3%) in cases where financial up-gradation becomes due with effect from 1st July 2010 on thereafter."

Amendment of Rule 12:

Below proviso (i) to Rule 12, a new provision '(a)' shall be inserted as follows:

"(a) The rate of increment as mentioned in proviso (i) above shall be 'three per centum (3%) in cases where fixation on promotion becomes due with effect from 1st July 2010 on thereafter."
