
Subject: Release of further installment of Dearness Allowance @ 3% with effect from 1st July 2011 over the revised pay structure.

The undersigned is directed to refer to this Department's Memorandum No.F.5(4)-FIN(G)/09, dated 17-7-2010 on the above noted subject and to state that the Governor of Tripura is pleased to decide grant of further installment of Dearness Allowance @ 3% over the revised pay (Band pay + Grade Pay) with effect from **1st July 2011** to the State Government employees. With this release of installment, total quantum of DA payable to the State Government employees with effect from **1-7-2011** shall stand as **27%** (24% + 3%) over the revised pay.

2] Total admissible amount of DA shall be worked out in whole rupee. Fraction of a rupee below 50 paise should be ignored, while fraction of a rupee, 50 paise and above should be rounded off to the next higher rupee.

3] The above rate of DA would also be admissible for the employees of Agartala Bench of the Guwahati High court, TPSC, TBSE, Grant-in-Aid Schools and 7 non-commercial Autonomous Organizations viz. (i) Tripura State Social Welfare Board, (ii) Tripura State Pollution Control Board, (iii) TREDAs, (iv) State Council for Science & Technology, (v) Tripura Board of Wakf, (vi) Tripura State Cooperative Union and (vii) SIPARD.

4] Subject to availability/ generation of resources, PSUs, ULBs, TTAADC and other autonomous bodies may take decision for providing aforesaid installment of DA w.e.f. 1-7-2011.



Subject: - Release of further installment of Dearness Relief @ 3% with effect from 1st July 2011 over the revised pension to the State Government pensioners/family pensioners.

The undersigned is directed to refer to this Department's Memorandum No.8(3)-FIN(G)/09 dated 17th July, 2010 on the above noted subject and to state that the Governor, Tripura is pleased to decide grant of further installment of Dearness Relief @ 3% over the revised pension with effect from **1st July 2011** to the State Government Pensioners and Family Pensioners. With this release of installment, total quantum of Dearness Relief payable to the State Government Pensioners & Family Pensioners with effect from 1-7-2011 shall stand as 27% (24% + 3%) over the revised pension.

2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. The pension disbursing authorities including Public Sector Banks handling disbursement of pension/family pension to the State Government pensioners and family pensioners are authorized to calculate and disburse Dearness Relief at the above rates and manner from **1-7-2011**.

4. The expenditure on payment of Dearness Relief on Pension/Family pension to State Government pensioners and Family Pensioners is debit able to the Major Head '2071-Pension and other Retirement Benefits'






