MEMORANDUM

Subject: - Grant of 16% Dearness Relief on the revised pension to the State Government pensioners/family pensioners with effect from 1-1-2009 respectively.

Consequent upon revision of pension/ family pension of State Government pensioners/ family pensioners under the Tripura State Civil Services (Revised Pension) Rules, 2009, notified under Finance Department Notification of even number and date, it has become necessary to relate Dearness Relief admissible to the State Government Pensioners/ Family pensioners with their revised pension.

Accordingly the Governor is pleased to decide that 16% Dearness Relief shall be released to the State Government pensioners/ family pensioners with effect from 1st January, 2009 as follows;

Date from which applicable	Rate of DR per mensem
From 01.01.2009	16% of basic pension/family pension

2. The amount of Dearness Relief shall be worked out in whole rupee and fraction of a rupee below 50(fifty) paise shall be ignored while fraction of 50(fifty) paise and above shall be rounded off to the next higher rupee.

3. The pension disbursing authorities including Public Sector Banks handling disbursement of pension/family pension to the State Government pensioners and family pensioners are authorized to

calculate and disburse Dearness Relief at the above rates and manner from 1-1-2009.

4. The expenditure on payment of Dearness Relief on Pension/Family pension to State Government pensioners and Family Pensioners is debit able to the Major Head `2071-Pension and other Retirement Benefits`
